## TERMS OF SALE

**ACCEPTANCE OF SALES TERMS:** All orders submitted to TECH GEAR 5.7 shall be subject to the sales terms printed below. The undersigned agrees that s/he has knowledge of these terms and that they shall be binding upon the Purchaser with respect to any goods shipped by TECH GEAR 5.7 to the Purchaser.

**ORDERS FOR MERCHANDISE:** All orders submitted to TECH GEAR 5.7 are subject to approval by TECH GEAR 5.7. TECH GEAR 5.7 may, at its option, refuse any order placed by Purchaser if, in the opinion of TECH GEAR 5.7, Purchaser's credit has become impaired. TECH GEAR 5.7 may cancel any accepted orders or refuse or delay shipment of any order if Purchaser becomes delinquent in payment obligations or other credit or financial requirements established by TECH GEAR 5.7. In the event that Purchaser's account becomes delinquent, TECH GEAR 5.7 may require, as a condition of continuing to do business with Purchaser, that Purchaser execute a Promissory Note(s), Security Agreement(s), Financing Statement(s), and such other instrument(s) as TECH GEAR 5.7, in its sole discretion, deems necessary for its protection.

**TERMS OF SHIPMENT:** Unless otherwise agreed in writing, all orders are Net 30 (subject to credit approval by TECH GEAR 5.7) or cash in advance, F.O.B. US warehouse, with shipping charges added to Purchaser's invoice as determined by TECH GEAR 5.7 unless the order qualifies for prepaid freight. TECH GEAR 5.7 will select the method of shipment unless otherwise agreed with the Purchaser. Unless Purchaser advises TECH GEAR 5.7 to the contrary in writing, TECH GEAR 5.7 may make partial shipments on any order. Each shipment shall be invoiced and paid for when due, without regard to subsequent deliveries.

**CLAIMS:** Acceptance in good order by carrier from TECH GEAR 5.7 makes shipment the property of the consignee. All claims for damage, breakage or losses (concealed or obvious) must be made within the time specified by ICC regulations. Claims for adjustments on short or otherwise unsatisfactory merchandise must be made to TECH GEAR 5.7 within 7 days of receipt of shipment. TECH GEAR 5.7 reserves the right to examine, at Purchaser's location, any merchandise claimed to be defective, and to inspect any merchandise and applicable shipping records in claims of "short-shipment".

**RETURNS AND EXCHANGES:** All products returned to TECH GEAR 5.7 for any reason must be shipped prepaid. Products will be accepted for credit or exchange only with prior authorization from TECH GEAR 5.7. Shipment not identified on exterior of shipping carton by authorization number will be refused. Credit will be issued only after merchandise is inspected and approved and will be based on the Purchaser's cost for the products in question, less any necessary cost for repair, refurbishing or repackaging.
