SALES TAX RULES AND REGULATIONS-RESALE CERTIFICATES

To Our Customers:

In compliance with Sales and Use Tax Laws it is necessary that we have from all our customers a signed re-sale certificate, with their State Sales Tax Permit Number, to show that the merchandise has been purchased for re-sale. Under "Description of property to be purchased" there may appear:

1. Either an itemized list of the particular property to be purchased for resale,
OR
2. A general description of the kind of property to be purchased for resale.

Such certificate is good until revoked in writing. Please insert a photocopy of your SALES TAX PERMIT NUMBER, WITH YOUR SIGNATURE AND ADDRESS ON THE BELOW
